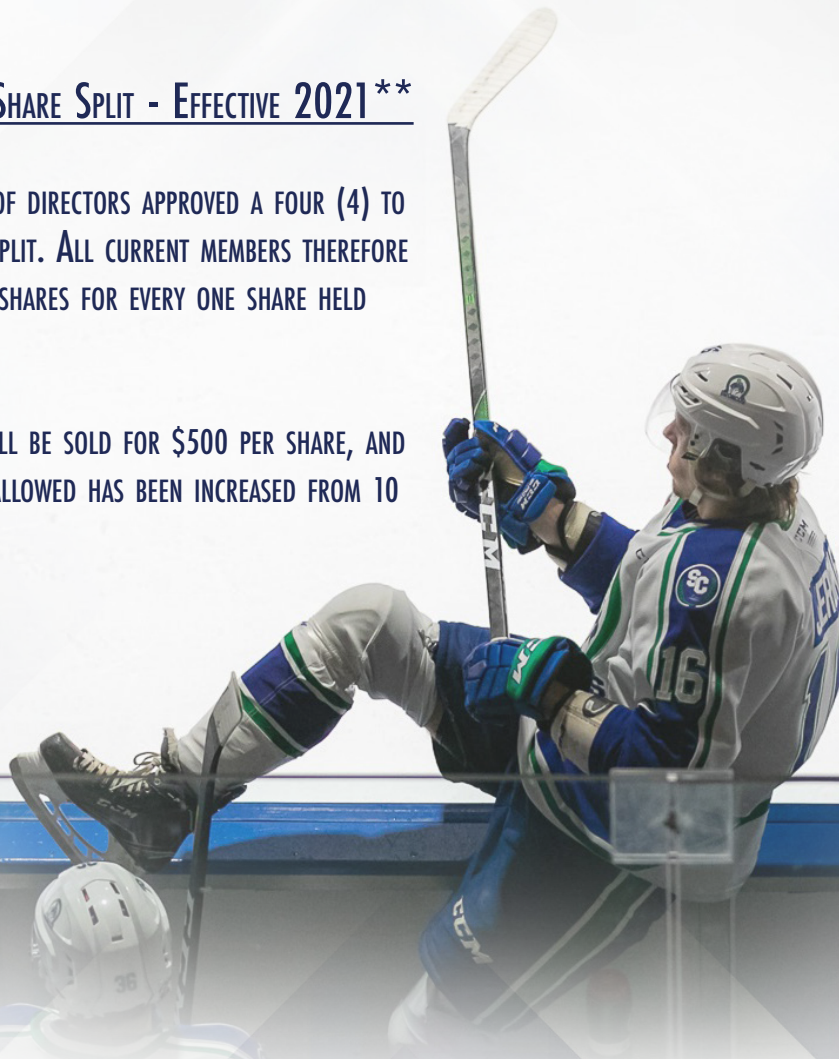
- ACCESS TO AND VOTING PRIVILEGES AT THE AGM AND ANY MEETING OF THE MEMBERS

4 TO 1 MEMBERSHIP SHARE SPLIT - EFFECTIVE 2021

EFFECTIVE 2021, THE BOARD OF DIRECTORS APPROVED A FOUR (4) TO ONE (1) MEMBERSHIP SHARE SPLIT. ALL CURRENT MEMBERS THEREFORE NOW HAVE FOUR MEMBERSHIP SHARES FOR EVERY ONE SHARE HELD PREVIOUSLY.

NEW MEMBERSHIP SHARES WILL BE SOLD FOR \$500 PER SHARE, AND THE MAXIMUM # OF SHARES ALLOWED HAS BEEN INCREASED FROM 10 TO 40.





QUALIFICATION AND LIMITS

- APPLICATIONS MUST BE SUBMITTED TO THE BOARD FOR APPROVAL
- LIMIT OF 40 MEMBERSHIP ISSUES PER INDIVIDUAL OR ORGANIZATION
- EACH MEMBERSHIP PURCHASED ENTITLES THE PERSON/ORGANIZATION TO ONE VOTE AT THE ANNUAL GENERAL MEETING
